

Privacy Policy & Terms of Use – goSeeYou

Here is our privacy policy, terms and condition for users of the goSeeYou mobile app and website www.goseeyou.com. Please read our privacy policy carefully if you use our services. By using our website or our application, you accept the practices described in this Privacy Policy.

Eligibility.

You must be at least 18 years old to create an account and use our services. By creating an account and using our services, you confirm that you agree to:

- you can form a binding contract with goSeeYou,
- You will comply with this Agreement and all applicable local, state, national and international laws, rules and regulations, and you have never been convicted of a felony and that you are not required to register as a sex offender with any state, federal or local sex offender registry.

Community Rules.

By using our services, you agree to receive emails from goSeeYou. You can choose to unsubscribe from this list by clicking on the dedicated link.

By using our services, you agree to create a profile in your name including at least 3 clear pictures of you, a respectable description, your age and access to your geolocation. Your profile could be hidden or banned without notice and without refund if one of these five conditions is not respected.

By using our services, you agree that you will not:

- use our services for any purpose that is illegal or prohibited by this Agreement.
- spam, solicit money from or defraud any users.
- impersonate any person or entity or post any images of another person without his or her permission.
- bully, “stalk,” intimidate, harass or defame any person.
- post any Content that violates or infringes anyone’s rights, including rights of publicity, privacy, copyright, trademark or other intellectual property or contract right.
- post any Content that is hate speech, threatening, sexually explicit or pornographic; incites violence; or contains nudity or graphic or gratuitous violence.

- post any Content that promotes racism, bigotry, hatred or physical harm of any kind against any group or individual.
- solicit passwords for any purpose, or personal identifying information for commercial or unlawful purposes from other users or disseminate another person's personal information without his or her permission.
- create another account if we have already terminated your account, unless you have our permission.

We reserves the right to terminate your account without a refund of any purchases if you have misused our services or behaved in a way that we regards as inappropriate or unlawful.

In App Purchases.

For specific features we offer products and services for purchase (“in app purchases”) through iTunes, Google Play or other application platforms authorized by us (each, a “Software Store”). If you choose to make an in app purchase, you will be prompted to enter details for your account with your Software Store (“your IAP Account”), and your IAP Account will be charged for the in app purchase in accordance with the terms disclosed to you at the time of purchase as well as the general terms for in app purchases that apply to your IAP Account. Some Software Stores may charge you sales tax, depending on where you live. If you purchase an auto-recurring periodic subscription through an in app purchase, your IAP Account will be billed continuously for the subscription until you cancel. After your initial subscription commitment period, and again after any subsequent subscription period, your subscription will automatically continue for an additional equivalent period, at the price you agreed to when subscribing. If you do not wish your subscription to renew automatically, or if you want to change or terminate your subscription, you will need to log in to your IAP account and follow instructions to cancel your subscription, even if you have otherwise deleted your account with us or the mobile application from your device.

Information collection.

Please note that we may collect information that may identify you, such as your name and email address and other information that does not identify you. We may collect this information via our website or mobile app. By using goSeeYou, you authorize us to collect, analyze and store data relating to the provision of the Service. When you provide personal information via our services, your information can be sent to servers located in Canada and around the world.

You will be able to log in to goSeeYou using your Facebook ID or email. You then allow us to access certain Facebook account information, such as your Facebook profile (according to your Facebook privacy settings), your e-mail address, interests, tastes, gender, birthday, school history, hometown, photos, personal description, friends list and information and photos of your Facebook friends who could be Facebook friends with other goSeeYou users. You will also be prompted to allow goSeeYou to collect your location information on your device when you download or use goSeeYou. We may collect and store all personal information you provide when using our services. This may include credentials, such as your name, address, email address and phone number. You can also provide us with photos, a personal description and information about your gender and preferences for recommendations, such as search distance, age range and gender. If you are discussing with other users of goSeeYou, you provide us with the content of your conversations, and if you contact us via our customer service or for another investigation, this communication could be recorded.

We collect information automatically from your browser or device when you visit our service. This information may include your IP address, the ID and type of your device, the type and language of your browser, the operating system used by your device, access times, the location of your mobile device while our application is activated and the address of the referring site. When you visit our service, we may assign your device one or more cookies to facilitate access to our service and personalize your experience. Through the use of a cookie, we may also automatically collect information about your activity on our Service, such as the pages you visit, the time and date of your visits and the links you click on. If we advertise, we (or third parties) may use certain data collected from our services to publish goSeeYou ads on other sites or applications.

Mobile Device ID: If you use our app, we use mobile device identifiers (the unique identifier assigned to a device by the manufacturer) or advertising IDs (for iOS 6 and later) to recognize you. We do this to store your preferences and track your use of our app. Unlike cookies, device IDs cannot be deleted, but ad IDs can be reset to "Settings" on your iPhone. Ad companies also use device IDs or ad IDs to track your use of the app, track the number of ads displayed, measure ad performance, and show ads that are more relevant to you. Analysis companies use device IDs to track application usage information. We may authorize service providers, advertising companies, advertising networks and other third parties to post advertisements on our Service. These companies can use tracking technologies, such as cookies or web beacons, to gather information about users who view or interact with their advertisements.

When you register as a goSeeYou user, your profile will be visible to other users of the Service. Other users (and in the case of any sharing features available on goSeeYou, individuals or applications with which a SeeYou user can choose from you with sharing) will be able to view the information you have provided us directly or through Facebook, such as your Facebook photos, additional photos you upload, your first name, your age, approximate distance, your personal description, and the information you have in common with the person viewing your profile, as common Facebook friends and likes. If you chat with your match, of course, your match will see your conversation's content.

Information disclosure.

We do not share your personal information with others except as stated in this privacy policy or when we inform you and give you the opportunity to not share your personal information. We may share personal information with some of our service providers. We may share information, including personal and financial information, with third parties who perform certain services on our behalf. These services may include fulfilling orders, providing customer service and marketing support, conducting business and sales analytics, tracking and analyzing ads, member reviews, support services features and competitions, contests and other features offered by our service. These service providers may have access to the personal information necessary for the performance of their duties, but are not permitted to share or use it for other purposes.

We may provide your personal information in these situations: In response to a subpoena or similar inquiry, a court order or a cooperation request from a law enforcement agency or other government agency ; To establish or exercise our legal rights; To defend themselves against claims; Or otherwise required by law. In such cases, we may waive or waive any objection or legal right at our disposal. Where we believe that disclosure is appropriate in the context of efforts to investigate, prevent or otherwise take action regarding illegal activity, suspicion of fraud or other improper conduct; Protect and defend the rights, property or security of our company, users, employees or third parties; Comply with applicable law or cooperate with law enforcement; Or to enforce our Terms of Use or other agreements or policies.

Aggregated and / or non-personal information.

We may use and share non-personal information that we collect in any of the above circumstances. We may also share aggregated, non-personal or personal information in a nonhuman, non-human readable form with third parties, including advisors, advertisers and investors, for the purpose of conducting general business analyzes or other commercial purposes. For example, we can hire a data provider that can collect web log data (including IP address and information on your browser or operating

system), or place or recognize a unique cookie on your browser for you to receive custom ads or content. Cookies may reflect unidentified demographics or other data related to data you voluntarily submitted to us (such as your email address) that we can share with a data provider only in chopped and unreadable form human. If you have a SeeYou account, you have the option to review and update your personal information in our services by opening your account and going to the settings. You can also close your account at any time by visiting the "Settings" page of your account. If you close your account, we maintain certain information associated with your account for analysis and integrity of record keeping, as well as to prevent fraud, enforce our Terms of Use, take action that we believe necessary to protect the integrity of our Service or our users, or take other measures provided for by law. In addition, if certain information has already been provided to third parties as described in this Privacy Policy, the retention of such information will be subject to the policies of such third parties. Your choices about collecting and using your information you may choose not to provide us with certain information, but this may prevent you from using certain features our services, as such information may be required to register you as a user; buy products or services; participate in a contest, promotion, survey or raffle; or initiate other transactions. Our service can also send notifications to your phone or mobile device. You can disable these notifications by going to "Application Settings" on the application or website by changing the settings on your mobile device. You can also control the information collected by cookies. You can remove or reject cookies by changing the settings of your browser. Click "Help" on the toolbar of most browsers for instructions.

How We Protect Your Personal Information

We take security measures to protect your personal information from unauthorized access and disclosure. However, no system can be completely secured. Therefore, even if we take steps to secure your information, we do not promise, and you should not expect that your personal information, chats or other communications will always be secure. Users should also take care of how they process and disclose their personal information and should avoid sending personal information through an unsecured electronic mail. We provide areas on our Service where you can view information about yourself and others and communicate with others. These messages are governed by our terms of use. In addition, whenever you voluntarily disclose personal information on publicly accessible pages, this information will be made available to the public and may be collected and used by others. The most recent version is the version that applies. The name goSeeYou and or domain name may change without notice and continue to use your data and information provided. Please carefully review the changes. Your continued use of our services after posting changes to this policy means that you consent to these changes and accept them. If you do not consent to such changes, you can delete your account by following the instructions under Settings.

- Your date of birth, your gender, your sexual orientation, first and last name, approximate geolocation, date and time of creation of accounts and last connection, email address, at least 3 clear photos of you or at least 3 photos linked to your account Facebook (if you have chosen this connection method)

By accepting the terms and conditions of use you also agree to create a profile and to add to it voluntarily, but without obligation, information such as:

- Your interests, family status and type of work schedule. You can share information about your lifestyle or personality in your description. You can give us access to your photo gallery or photo album if you choose to add photos manually. By agreeing to provide this information, you also agree to let us manage it and you accept that it will be visible to other users.

We collect this information in order to present you the profiles close to you and corresponding to what you are looking for according to the information shared in your

profile, but also to comply with legal requirements. All the information contained in your profile is visible to other users.

What you decide to exchange via private messaging is your sole responsibility and remember that it can be used by the person to whom you send this information and cannot be held responsible for it.

For the protection of all our users including you, we may ask you to provide proof of identity before we can authenticate you.
